- 2. Citizens Comments (sign-up required 3 minutes)
 - Laura Rainey Submitted two applications to be approved for the Planning Commission Jane Frye & Calle Walters.
 - Scott Larsen Ballfields asked if the group that rented it was still maintaining it and asked for any updates that could be given.
 - Wayne Huey Veterans Memorial made mention that there has been quite a bit of discussion on Facebook regarding this and it seems that most people think that Wardlaw Park would be the ideal place for this memorial. Asked the Mayor and Council to work with the PHC on this so the project can begin for the community.
 - Larry Coker Veterans Memorial advised the Mayor and Council that the PHC has \$100,000 to build this, the PHC has talked about several areas
