- 3. Citizen's Comments
  - a. Amber Chaney Hello council members and fellow citizens of Pelzer my name is Amber Chaney, and I am a concerned citizen regarding recent actions lies and abuse of power by councilmember Donna Ide towards community member Kimberly Majors. Unfortunately, Kimberly Majors is unable to be here tonight. She runs a small business, and they have their auction every Tuesday at seven, but I am her sister so I'm here to speak on her behalf. I have copies of emails she let me have all the correspondences that happened between her and Miss Ide. So, if anyone is interested in the copies, I did not make enough copies. I did not know that there would be this many people here. But to summarize what has happened on July 14, Miss Ide reached out to Miss Major stating that a unanimous vote has taken place, again amongst the council members to increase the rental rate for the Zumba class that Miss Majors holds here in the Pelzer gym. It was later revealed by councilmember Miss Alicia Tuttle that no unanimous vote had taken place. But then in another email sent on July 17 Ms. Ide told Miss Majors that Mayor Ragland himself had asked her to reach out about the decision, and if a contract needed to be drafted, this has often been shared to be untrue. Since all this unfolded, Ms. Ide has remained silent. She has not reached out to anyone, including Ms. Majors, to offer an explanation or at least an apology for what happened. Her silence is yet another mark against her character, in my opinion. Pelzer deserves council members who will be honest, authentic, and be willing to own their missteps when they may have heard it makes, I can call this much controversy over a Zumba class. I for one fearful of what LG is capable of for the citizens of Pelzer. I have grown up in Pelzer my entire life. I only moved away to attend college and graduate school and I inherited my grandparents' home and have restored it. Unfortunately, I did not even realize that there was a need to be involved in town council. I was ignorant of that. But moving forward I plan to be here at as many meetings as I can because we Pelzer Our citizens deserve members of council who are number one going to be honest it up fold the truth and not misrepresent themselves and abuse their power. And I believe that is what we've seen in these emails by this time. blatantly lying is not a good look for a council member. And I hope tonight that Miss Ide can provide answers for her actions. And ultimately, I hope that we eventually see her resignation from Council.

- b. Theresa Howard Thank you for the opportunity to speak, I am also part of the dance class here at the Pelzer gym. I am not a Pelzer citizen, I am from Greenville, South Carolina drive from Greenville every Monday and Thursday nights to attend this dance class. I am a diabetic and I have struggled with diabetes for a while insulin dependent. I came with the hopes of getting results medically to better myself and that is exactly what I found in coming here. I had a friend that invited me, and I have been coming ever since paying \$5 to class for an hour and I am telling you Kim pours her heart out in our dance class. She gives us more than what I would give within an hour at any gym. She is a motivator. She is an encourager. And since coming and I want to say I have fallen in love with the town of Pelzer. You all are just kind citizens; I have not met anybody that unkind. I have supported some of your businesses here, especially the Mexican restaurant, which I dearly love. And so, I just feel compelled to bring you tonight, a definition of what it means to be unethical. You all took an oath when you were elected by your people to this office. And I also want to stop and just say, I appreciate you, Mayor, for being honest and coming forward. I appreciate you for coming to our dance class. And talking with us. I appreciate the fact that I introduced myself to you tonight. And you have already extended the opportunity to talk with you even after meeting. So, I just want to say thank you. Unethical, Here's the definition of unethical, not conforming to a high moral standard, morally wrong, not ethical, illegal, and unethical business practices, immoral and unethical behavior. This is why your council woman has presented when she did what she did. It is unethical. And I just want to say I do think that she should resign her position if nothing else for being unethical and not getting a vote. - d. **Scott Larsen** on behalf of the Election Commission recommended the Town Council to appoint Kelly Rugerio as a candidate for the Election Commission. She and her family have lived here for a few years.
