COUNCILWOMAN BEAR REQUESTED THAT TOWN CLERK MAKE COPIES OF ALL BIDS FOR EACH MEMBER OF COUNCIL, COUNCILMAN WAITS SUGESSTED THAT WE GET REFERENCES, CHECK BBB, SEE IF THERE ARE ANY COMPLAINTS FILED AND NUMBER OF YEARS IN BUSINESS.

RENTAL OF PELZER GYM – HAD A DISCUSSION OF PROS AND CONS OF RENTING OUT THE PELZER GYM, LIABILITY RISK, HOW IT WAS TO BE HANDLED, POSSIBLY INSTALLING A LOCK LIKE WE HAVE AT COMMUNITY BUILDING. COUNCILMAN WAITS SAID WE NEED TO CHECK THE EMERGENCY DOOR TO MAKE SURE IT IS EQUIPPED WITH A PANIC BAR.

DRIVETHRU WINDOW – MAYOR SCOTT RECEIVED THE WINDOW FROM THE BANK IN WILLIAMSTON FREE, WHY IS IT NOT INSTALLED. COUNCILWOMAN BEAR STATED THAT SHE'S HAD SEVERAL PEOPLE QUESTION HER AS TO THE INSTALLATION OF THE WINDOW. ALL MEMBERS FEEL IT WOULD BE A BENEFITS TO THE RESIDENTS WHO HAVE A DIFFICULT TIME COMING INTO THE OFFICE TO PAY THEIR WATER BILLS. TOWN CLERK STATED THAT IT WOULD BE HELPFUL AS LONG AS IT IS ONLY USED FOR PAYING YOUR BILLS, AND NOT TO DISCUSS ISSUES, ALSO WOULD BE A GOOD IDEA TO HAVE A DROP BOX THERE AS WELL.

COUNCILMAN WAITS BANNER'S – FLEA & FARMER'S MARKET – HE STATED THAT WE NEED TO PROMOTE OUR OWN TOWN AND TOWN EVENTS, SO HE THOUGHT WE COULD HELP PROMOTE THE FLEA & FARMER'S MARKET USING BANNERS THROUGHOUT THE TOWN. HE HAS REQUESTED INFORMATION ALONG WITH PRICING TO BRING TO MAYOR AND COUNCIL FOR DISCISSION ON THIS MATTER.
